**Maintenance of a register for healthcare workers exposed to COVID 19 at  
health care institutions**

As you are aware, a few health care workers have been exposed to patients with COVID 19 during work, and are being quarantined at the moment. It is vital that a record of all such healthcare workers is maintained at each institution.

Therefore, health institutions are requested to maintain a **register of all healthcare workers** who have been advised to be self-quarantined following exposure to confirmed COVID 19 patients. Any healthcare worker already in self isolation should also be included this register.

The register should include the following information and can be maintained in a CR book:

1.	Name	6.	If known, name of the suspected or positive patient
2.	Age	7.	Details of exposure. (Date, Time, Place of exposure, Type of PPE used (Surgical masks, N 95 masks, Goggles, Gowns, Aprons etc.)
3.	Sex	8.	Date of start of self-isolation
4.	Designation	9.	Date of completion of self-isolation
5.	Place of work (OPD/Ward/ICU/ Laboratory etc.)
